Room Valentia B+C, Melia Hotel, Valencia, Spain September 7th 2024, 18:15-18:50

- 1. DFSG Chairperson Nikolaos Papanas welcomed the DFSG members.
- 2. Minutes of the last Business Meeting: The members approved the minutes from the last Business Meeting held 17th September 2022 in Bratislava.
- 3. DFSG 2024 and DFSG organisation finances were presented by DFSG treasurer Roberto Anichini. The result of the DFSG 2024 is positive and the participant numbers are 236. The organisation's economy is good.
- 4. The DFSG executive committee suggests to re-phrase the officers' titles in the DFSG statutes, from "man" to "person". The DFSG members approved the alteration of the statutes.
